From 2018 to 2022, Dönges was Managing Director of Finanzagentur GmbH in Frankfurt, a financial services company in the Federal Republic of Germany. Since 2023, she has been a member of the executive board and CFO of listed Uniper SE. She was also a long-standing member of the supervisory board of Commerzbank AG and is a member of the supervisory board of TUI AG. In addition, she is a member of the board of directors of Deutsches Aktieninstitut.
